DURING 2019, VARIOUS DENTAL AND AUDIOLOGY SERVICES SUCH AS EXAMS, DEBRIDEMENT'S, X-RAYS, EXTRACTIONS, FILLINGS, DENTAL APPLIANCES AND HEARING AIDS WERE PROVIDED TO PATIENTS BY QUALIFIED LICENSED PROFESSIONALS. VAS STAFF PROVIDED COORDINATION OF SCHEDULING BETWEEN THE FACILITIES AND THE PROFESSIONALS, AS WELL AS BILLING FOR THEIR SERVICES.
